\$24 per event plus \$6 all events (scratch and/or handicapped)

- 1) Entry Deadline: Reserve entries/payment must be received no later than September 6, 2024. Walk-ins OK if space available.
- 2) Eligibility: **All bowlers must be current members of USBC.** Bowlers must be one of the following: active SIR members; those with SIR applications pending; guest of a SIR member (man or woman 50 years or older); wives or widows of SIR members, regardless of age.
- 3) Multiple Participation:
 - a) This is a **Doubles and Singles** tournament. With a different partner, a bowler may bowl and cash two times in the **Doubles** event.
 - b) One bowler must be a SIR member in **Doubles**.
 - c) A bowler may bowl **Singles** only one time.
 - d) The first **Doubles** score will be used for **All Events**.
- 4) Handicap: This is a handicapped tournament based on 100% of the difference between 230 and the bowler's average in Singles and 100% of 460 for Doubles.
- 5) Entering Average: **Entry average requirement is listed in order of decreasing priority.**
 - a) 2023-24 USBC Standard Composite Average (21 games or more). IF NONE;
 - b) 2022-23 USBC Standard Composite Average (21 games or more). IF NONE;
 - c) Current **verifiable** USBC sanctioned league average of 21 games or more at entry time by supplying secretary signed current league sheet at check in.
 - d) If average is unverifiable, entrant must bowl scratch (average of 230 = zero handicap).
Averages verified on www.bowl.com will require no further verification. **USBC Rule 319a. 1-4 is waived.**
- 6) Divisions: There will be **three** Divisions in Singles and All Events. Divisions **1** and **2** will be a men's division divided by average after close of mail-in entries. Division **3** will be a Women's Division. Doubles will have two divisions divided by average after close of mail-in entries. Scratch All Events will not have any divisions.
- 7) Entry Fees/Expenses:
\$24.00 per event: Singles/Doubles/, \$6.00 optional All Events (Scratch and/or Handicapped).
Lineage: \$11.00; Expenses: \$2.00, SIR State Fee \$1.00; Prize Fund: \$10.00
- 8) Prize Fund: All Prize funds will be returned 100% on a ratio of at least one to every five entries per Division including optional All Events. Prize money will be mailed to Team Captain/Prize Coordinator listed on entry form.
- 9) **SIR BRANCH 160 BOWLING COMMITTEE IS ADDING \$500 TO THE PRIZE FUND!**
\$100 to each of the three singles divisions and \$100 to each of the two doubles divisions
- 10) Refund Policy: Rule 314 is waived. Tournament fees paid for any event not bowled shall be returned to the bowler(s), unless a substitute bowls.
- 11) Disputes: All USBC rules governing certified tournaments shall apply in any case not covered above. The Branch 160 Tournament Managers, in consultation with the Tournament Committee, will resolve all disputes and problems not covered by these rules or USBC Tournament Rules. Their decision is final.
